Title: Training for Resilience: Mitigating Adverse Childhood Experiences in Higher Education

Summary: The goal of this project is to empirically investigate whether we can create organizational and cultural changes to mitigate the effects of Adverse Childhood Experiences (ACEs) through the implementation of trauma informed practice (TIP) trainings within an academic unit from top down (admin, faculty staff) and bottom up (students). Specific questions include: Does TIP training work in changing knowledge and behavior in the short term and does implementation coaching help maintain these changes across time?" Additionally, "What is the incidence of ACE's among students in the College of Pharmacy?" and "Does TIP training have a measurable effect on student success?"

Title: Reflective Supervision and Consultation in the Infant and Early Childhood Mental Health Workforce
